AN ORDINANCE FOR THE PURPOSE OF AMENDING THE TOWN OF KENNETH CITY LAND DEVELOPMENT CODE CHAPTER 82 ZONING ARTICLE III ZONING DISTRICTS COMMERCIAL GENERAL SECTION 82-352 TO REGULATE AND ALLOW FOR EXISTING AND FUTURE AUTOMOTIVE SERVICE AND REPAIR FACILITIES AS GENERAL COMMERCIAL USES WITHIN THE COMMERCIAL GENERAL ZONING DISTRICT, PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
